





उन्होंने कहा, 'नए मामलों में से दो मरीज हाल ही में दिल्ली से लौटे और यहां एक संस्थागत पृथक-वास केंद्र में हैं, जबकि एक महिला संभवतः अपने पिता के संपर्क में आने से इस बीमारी की चपेट में आई। महिला के पिता को 13 जून को संक्रमित पाया गया था।' लालमलसावमा ने कहा कि घबराने की कोई जरूरत नहीं है क्योंकि महिला को संक्रमित पाए जाने से पहले ही घर पर पृथक-वास में रखा गया था। उन्होंने कहा कि महिला को बुधवार सुबह जेडएमसी में भर्ती कराया गया था।
